### **Beat the Odds Program Description**

The Prince William County Bar Association, in association with the Prince William County Bar Foundation and local government agencies, proudly sponsors the nationally recognized Beat the Odds® program, originally developed by the National Children's Defense Fund for the benefit of local youth. This annual program recognizes and encourages the 31st Judicial District's youth to overcome significant obstacles that interfere with their ability to reach their full social and academic potential.

Each year a select group of candidates, nominated by agency caseworkers, probation officers, school personnel, and attorneys, submit applications to be considered for an award. The candidates are selected from local youth who have come into contact with the 31st Judicial District Juvenile and Domestic Relations Court, the Court Services Unit, the Community Services Board, the local school systems and the Departments of Social Services of Prince William County or the Cities of Manassas or Manassas Park, and have overcome significant obstacles to achieve remarkable educational and social progress. These recipients are then honored at a formal celebration when the community gathers with the recipients and their friends and families at a formal awards banquet to hear their remarkable stories as they are presented with a scholarship or other educational or vocational award.

### **AWARD SELECTION GUIDELINES**

The Prince William County Bar Association (PWCBA) Beat the Odds® Program, in conjunction with the Children's Defense Fund's (CDF) **Beat the Odds® Awards**, focuses attention on the positive potential of the youth involved with the 31<sup>st</sup> Judicial District and residing in Prince William County and the Cities of Manassas and Manassas Park. The PWCBA Beat the Odds® Committee is working with the local departments of Social Services, the Juvenile Court Service Unit, the J&DR Clerk's Office, the Community Services Board, and the local schools to select and honor youth who demonstrate the strength and determination to *Beat the Odds*®.

### **Objective:**

The objective of the PWCBA's *Beat the Odds*® Program is to celebrate and encourage the positive potential of our community's youth who are able to overcome significant obstacles in order to achieve substantial social and academic progress to become positive and productive members of our society.

### **Background:**

The Children's Defense Fund (CDF) developed the Beat the Odds® program in 1990 as a means to celebrate and underscore the positive potential of our nation's youth. The Prince William County Bar Association began running the Beat the Odds® celebrations in 2001. The students honored have demonstrated academic excellence, personal achievements in their struggles to improve their own lives and the lives of others, and the strength and determination to accomplish this by beating the odds. The PWCBA celebrates the remarkable lives of these young people as well as the family, friends, teachers, and counselors who help them to achieve.

### The Two Award Categories and Criteria:

The PWCBA has modified and expanded the award categories to respond to the unique needs of the children in the 31<sup>st</sup> Judicial District. In recognition of the fact that not all youth who have successfully overcome significant difficulties to establish themselves firmly on the road to success choose to go on to college and some may not be old enough to be contemplating this decision, the PWCBA has created an additional category of award to recognize youth who have positive goals and aspirations other than college. There shall be two levels of recognition, each level having separate criteria and corresponding awards consistent with the level of achievement and the recipient's educational and developmental goals. The award recipients shall be chosen according to the following guidelines by the PWCBA Beat the Odds® Committee and, in addition to an award, the recipients will be given two additional free banquet tickets for two

guest. When thinking of a youth deserving of these honors, keep in mind the following guidelines for the two different categories. These guidelines should be considered a **working outline for your written nomination statement**.

### **AWARD CATEGORIES:**

- I. Beat the Odds® Scholarship Awards. The Beat the Odds Scholarship awards are the first category of awards that are awarded to graduating high school students and first year college students. Nominees must be:
  - A high school senior, enrolled in school in a public or private school with graduation imminent or be a student enrolled in his/her first year of college.
  - Succeeding despite, but not limited to, hardships such as poverty, disability, homelessness or personal tragedy.
  - Maintaining a grade point average showing marked effort, improvement or success.
  - Participating in activities, formal or informal, which are helpful to others.
  - A client or former client of the 31<sup>st</sup> Judicial District Juvenile and Domestic Relations
    District Court; the Court Service Unit; the Community Services Board; the
    Departments of Social Services of Prince William County or the Cities of Manassas
    or Manassas Park; or the local schools; or having demonstrated such other hardship,
    obstacle or life experience which, in the sole discretion of the PWCBA, qualifies the
    nominee for an award.
- II. Beat the Odds ® Phoenix Awards. The Beat the Odds Phoenix Awards are the second category of awards for goods and/or services that are designed to advance the recipient's educational or career or life goals. Goods and/or services may include, but are not necessarily limited to, tuition, course fees, test fees, vocational training, books, computer equipment, audiovisual equipment and tools of a particular trade or occupation. The particular goods and/or services awarded to each recipient would be tailored to the needs, interests and goals of the individual recipient. The nominator would assist in tailoring the award to the recipient. The PWCBA Beat the Odds ® Committee envisions the recipients of this award as youth who may still be of high school age, but not ready for college, or who are contemplating a GED and/or vocational training. Nominees for the Beat the Odds ® Phoenix Award must be:
  - Succeeding despite hardships that may include but shall not be limited to poverty, disability, homelessness or personal tragedy.
  - A client or former client of the 31<sup>st</sup> Judicial District Juvenile and Domestic Relations
    District Court; the Court Service Unit; the Community Services Board; the
    Departments of Social Services of Prince William County or the Cities of Manassas
    or Manassas Park; the local schools; or having demonstrated such other hardship,
    obstacle or life experience which, in the sole discretion of the PWCBA, qualifies the
    nominee for an award.

### **Submitting a Nomination and Application:**

When submitting nominations, the nominator must prepare a written statement of how this child fits within the above award guidelines and criteria, and return it with the rest of the Nomination and Application Forms to the Grace Lempp, President of the PWCBF, by April 11, 2025.

The nominator of the recipient of these awards will be expected to present the award to the honoree at the Beat the Odds® Banquet and will receive a free ticket to the banquet. Nominator must submit the nomination and supporting statement, along with the Nominee's Application, Release and Media Consent Form. This fully completed nomination and application package must be delivered by April 11, 2025 to:

### **The Selection Process:**

- The PWCBA Beat the Odds® Honoree Committee and the Bar Foundation Board will meet to review the nominations and select the award recipients.
- The PWCBA committee members will inform the nominators of the award recipients by phone and letters will be sent to the award recipients.
- The award recipients and their respective nominators will be required to attend a mandatory meeting to be held on May 6<sup>th</sup>, 2025, time and format to be determined. Award Recipients will be given further information and instructions about the awards and the banquet at that time. Complementary tickets for the awards banquet will be distributed to the recipients and the nominators and additional tickets will be for sale. Media representatives may be present to interview the nominators and recipients who are amenable to an interview.
